Chef's Choice and Dessert Competition –Sunday, August 7: Open to teams competing in the standard competition and to anyone that loves to barbeque and be a showcase for Pit At The Park during the 53rd Das Awkscht Fescht. Set up time options are 5pm – 7pm Saturday evening or starting at 7am on Sunday. This competition is not a part of the overall competition judging. You do not need to be a member of Kansas City Barbeque Society or be part of the Friday, Saturday competition to compete on Sunday.

Chef's Choice and Dessert categories are requested to be a dish relative to Pennsylvania Dutch style, not the basic barbequed meat. They will be judged on authenticity, appearance and taste. Anything prepared for Chef's Choice and Dessert must be prepared on site, one entry per team. Turn in time is 11:00am for Chef's Choice, 11:30am for Dessert. Anyone is eligible for cash prize. Highest cumulative score of 2 categories will be awarded grand prizes. Amateurs only are eligible for award prizes of new grills.

Entry cost for this competition is \$50.00. 1st Place takes \$400, 2nd Place takes \$200, 3rd Place takes \$100.

All prize money is guaranteed.
